This four (4.0) hour classroom instructor directed seminar using powerpoint slides to assist learning, is intended to prepare participants to be able to administer and enforce the 2012 IPMC, by locating, describing and applying the specific sections of the IPMC Code to determine compliance or noncompliance within the built environment. Upon completion, participants will be able to:

1. Identify and locate key sections of the IPMC Code
2. Describe the application of the Code to inspection and code enforcement
3. Apply Code requirements to problems similar to those encountered in the field.

This is a two (2.0) hour classroom instructor directed seminar using powerpoint slides to assist learning, presented in 2 (1) hour sessions. The first one (1) hour session will provide the legal aspects of Michigan Laws and Codes that influence and guide the work of code enforcement officers, including related court cases. The second (1) hour session will provide examples of interpersonal skills and discuss ways to improve those skills including effective writing and verbal presentations. Each participant will perform a self-analysis survey to discover their strengths and gain insight on how to improve both.
